VESSEL GENERAL PERMIT (VGP) ABOVE WATER LINE/DECK CLEANING

Vessel owner/operators must minimize the introduction of on-deck debris, garbage, residue, and spill into deck washdown and runoff discharges. Before deck washdowns occur, you must broom clean (or equivalent) exposed decks or use comparable management measures and remove all existing debris. The presence of floating solids, visible foam, halogenated phenol compounds, and dispersants, or surfactants in deck washdowns must be minimized. If deck washdowns or above water line hull cleaning will result in a discharge, they must be conducted with "minimally-toxic" and "phosphate free" cleaners and detergents as defined in Appendix A of this VGP (effective 12/19/13-2018).
