CITRA SOLV FLOATING does not contain any toxic or hazardous wastes such as xylene, toluene, benzene, perchlorethylene, 1,1,1, trichloroethane, trichlorethylene, or methylene chloride. Also, when compared to these highly toxic chemicals, this natural citrus product is considered as essentially:

ENVIRONMENTALLY SAFE, NON-CAUSTIC, NON-FUMING, VERY LOW IN TOXICITY, NON-CORROSIVE, NON-ACID, NON-FLAMMABLE, SAFE TO METAL PIPES AND BIODEGRADABLE.

DIRECTIONS FOR USE:

FOR PUMPING STATIONS, WET WELLS & SEWER LINES:

1. Add product directly into force mains and sewer lines as needed to remove grease build-up.
2. Allow product to drip directly into wet wells and pumping stations.
3. Product is not affected by temperature and may be used in sub-freezing temperatures.

TO ELIMINATE CAKE AND LIQUEFY GREASE:

Through any port or inspection opening, add 20 to 25 gallons of product immediately followed by the addition of 500 to 2000 gallons of water.
