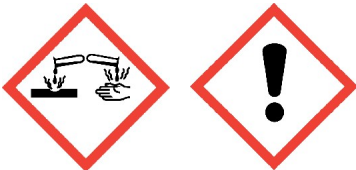

4 FIRST AID MEASURES

- Inhalation:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical advice/attention.

6 ACCIDENTAL RELEASE MEASURES
