

DESCRIPTION:

MASTER SCENT is a super concentrated deodorant that attacks odor sources and counteracts them. Use it to fight odors from smoke, urine, vomit, pets and mildew.

MASTER SCENT eliminates unpleasant odors fast! Ideal for use on odors found in sewer plants, carpets, floors, garbage containers, disposal units, toilets, urinals, closets, dirty linen baskets, cigarette urns, animal cages, kennels and garbage compactors.

Special vaporizing ingredients ensure quick and consistent neutralization of airborne odors.

DIRECTIONS:

1. Routine damp mopping and/or light cleaning and deodorizing: add 1 to 2 ounces to each gallon of water.
2. Carpet shampooing/deodorizing: add 1 to 2 ounces to each gallon of water.
3. Rinse water: add 1 to 2 ounces to each gallon of water.
4. Hand spraying/misting: add 4 to 8 ounces to each gallon of water.
5. Sewer plant treatment: drip concentrate to raw sewage at a steady rate.
6. Atomizing/fogging: product may be used as supplied or diluted 1:1 to 1:3 with water.
