4 FIRST AID MEASURES

Inhalation: Move to fresh air. Call a physician if symptoms develop or persist.

Ingestion: Do not induce vomiting without advice from poison control center. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Get immediate medical advice/attention.
