**DIRECTIONS FOR USE -**

Spray surface from the bottom up completely saturating all contaminated surfaces. Let dry completely. If any stain is still visible apply a second application and let dry. Light scrubbing may be necessary for tougher stains.

**MSR 100** may not be able to remove deeply embedded stains in tile grout, silicone, or drywall. Not for use in removing hard water deposits.

Some surfaces may require rinsing to prevent damage. Always pretest surface in an inconspicuous spot before using product.
